

## **DEMOSTRATIONS**:

Demonstrations of the solutions were held remotely via Microsoft Teams on August 10-11; August 13-14; August 17-18, August 20-21; and August 24-25, 2020.

#### SCORING:

Vendor responses were scored according to the RFP's scoring criteria. Anyone interested in receiving a copy of the scoring should contact the Lead State of Montana as identified on the portfolio's NASPO ValuePoint website.

#### AWARD:

The RFP allowed for multiple vendor awards based on each vendor's success in earning more than 3,000 of the 5,000 total possible points, on the Core Service and each Option, during the scoring portion of the evaluation process. One of the five evaluated vendors did not submit a response for Option A, therefor they were not scored on this Option; this vendor and the other four vendors all received total scores of more than 3,000 points on the Core Service and Options and all vendors were awarded a Master Agreement.
